### Women and Legal Rights

Objective:

Women are being subjected to various kinds of violence. Though we have number of laws and statues to deal with it, due to ignorance and less exposure, women are not able to avail or make use of those provisions. Therefore as per the directions of Hon'ble High Court of Madras while disposing Crl. Appeal Nos 428 & 534/2001, a special subject for students in Colleges and University Departments, has to be introduced, relating to the Laws of the Land under which they can seek appropriate remedies from the legal and legal rights to which they are entitled to such as, how to react and defend themselves in the event of any violence namely Eve teasing, Molestation, Sexual Harassment etc
